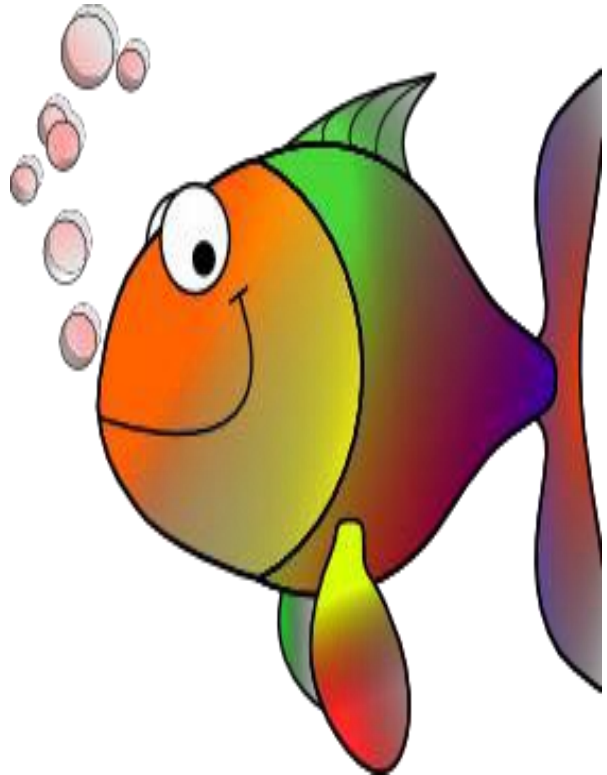

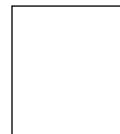

Happy New Year to you all!

We are beginning to get ourselves organized for another busy year in looking out for the interests of the boaters of California! RBOC recently held their election of officers for 2017

Peter Robertson is our 2017 President, Sacramento YC;
John Marshall, Southern Vice President, SCYA;
Ray Durazo, Northern Vice President., PICYA.

In addition, Maggie Sabbovich, Oakland YC, has been appointed as a Director replacing Dave Breninger who termed out after serving, I believe, twelve years on the RBOC Board of Directors.

I have agreed to serve for another year, but have hopefully lined up a replacement for the last two years of my three year term.

It appears that we have another busy year ahead of us.

Again, protecting the boater's dollars, as always, will be on the top of our list. We are trying to get out in front of the issue of raiding our boater's dollars for the removal of derelict commercial vessels. There is no funding program to specifically address this issue.

There are several issues since most of the problems are vessels that were built as commercial vessels, but have since been sold to private citizens or have been taken over by private citizens who for any number of reasons can no longer care for them in a responsible fashion. So, are they really commercial vessels or have they really become recreational vessels?

In the past CalRecycle has secured funding to clean up certain waterways, such as the Oakland Estuary, which in large part were abandoned commercial vessels. So, you will be hearing more about this as the year progresses.

Of course, funding RBOC's efforts is always an issue. Our primary source of funding is YOU!! We, again have a very effective lobbyist in Sacramento the Law/Lobbying firm of Desmond & Desmond. They have done a superb job over the many years, but that does cost money!

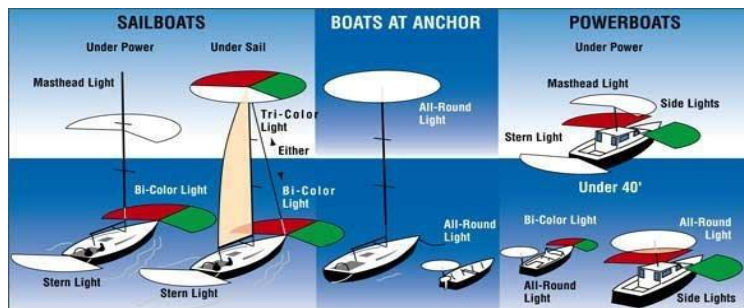

Light Up The Night- The right navigation lights are essential to safe pilot after dark.

Let's consider a scenario for a minute. You're heading out across the lake for a night of fishing. You have your navigation lights on. You are at the wheel and you have one of your crew members watching the horizon for any signs of vessels ahead. It's a big lake and it's dark, very dark. Perhaps you slow down a bit, but there is no "restricted visibility" so you are still moving quickly. Suddenly, out of nowhere, you strike another vessel and two people are killed. What went wrong?

This scenario happened. That's right, no lights. They were off to make it easier to gaze up at the stars. That simple mistake turned into a tragedy. Many of the cases involving collisions at night injuries or even deaths could have been prevented with the correct navigation lights used properly. But in the dark, the only way to see a boat and tell what direction it is moving is by its navigation lights. COLREGS define what navigation lights must be used at night and in restricted visibility so the same collision avoidance procedures can be taken.



COLREGS Part C - Lights and Shapes defines the lights and shapes that must be carried by different vessels in different conditions. First and foremost, the "Rules of this part shall be complied with in all weathers" from "sunset to sunrise" and "during such times no other lights shall be exhibited." The COLREGS even go so far as to say that "The lights prescribed by these Rules shall, if carried, also be exhibited from sunrise to sunset in restricted visibility." Bottom line? If it's hard to see, your navigation lights should be on.

Let's return to the situation we started with — the boat floating on the lake with no lights in the dark. This example helps to illustrate the COLREGS as an intertwined set of rules. Was the drifting vessel (motor off, not anchored) a vessel "underway"? Were they required to "post a lookout" per the COLREGS? Were they required to "take action to avoid collision"? Were they required to display their navigation lights? The answer is "all of the above." If they had taken the required steps, it's likely that there would have been no collision and two lives would have been spared. Unlike cars that need headlights to see, as mariners we count on navigation lights to allow us to be seen.

PROPOSED BYLAW CHANGES

From the Bylaws Committee: Rich Irwin, chair; George Iaconis; Joan Marsh; Gary McGrath
Bylaws Amendments Approved by the Board of Directors, December 11, 2016
Published in January Yeoman; Discussion and Vote at the January 13th, 2017 General Meeting

Here is a brief explanation of the changes being proposed to the membership:

- 1. Remove any specific dues amounts or percentages from the bylaws.*
- 2. Add and define Life Membership as a classification, based on a long standing practice.*
- 3. Allow more choices for paying dues by installment for "Full" and "Individual" members, delete the current April 1 deadline. (Note that the Board approved Installment Plan and information was printed in the December Yeoman. Members will vote on this item and new dues fees at the January General Meeting.)*
- 4. Remove a provision that calls for certain PYC officers to be directors of PYC Enterprises, Inc. Those yacht club offices are named in the PYC Enterprises bylaws since it is their board of directors.*
- 5. Remove requirement that each Director shall chair a Standing Committee.*
- 6. Add the Audit Committee, previously part of the bylaws but inadvertently removed, in the December 2012 edition.*
- 7. Words to be deleted are ~~lined through~~; Words to be added are underlined.*

ARTICLE II - MEMBERSHIP

Section 2

There shall be ~~seven~~eight (7~~8~~) Classifications of Membership: (1) Full Membership, (2) Individual Membership, (3) Non-Resident Membership, (4) Cruising/Traveling Membership, (5) PICYA Affiliate, (6) Temporary or Guest Membership, ~~and~~ (7) Corporate Membership, and (8) Life Membership.

- (1) Full Membership:** This is the broadest form of membership for up to two (2) voting members related as family or domestic partners. For purposes of these Bylaws, a Domestic Partnership shall be defined as two people living in the same residence. This shall include members who have minor children who will be considered part of the PYC family. Full memberships will pay ~~100% of the any~~ Initiation Fee upon application and will pay ~~100% of full~~ Full dues and any assessment levied. This membership will have members' names and contact information included in the roster and will receive official name tags for both members. Full Memberships will have full privileges (voting, hold office and serve on any committee) and privileges for the use of the clubhouse during regular club hours and may participate in an unlimited number of club-sponsored dinners and events.
- (2) Individual Membership:** This is membership for an individual (1) voting member. Individual memberships will pay ~~100% of the any~~ Initiation Fee upon application and ~~two-thirds (2/3) of the full individual~~ dues and any assessment levied. An Individual Membership will have the same club privileges as Full Members. An Individual Membership may be upgraded to add another person to the Membership by payment of the difference in dues between the two classifications (Individual and Full).

- (3) **Non-Resident Membership:** This is available to existing Members in good standing and who have or who are going to relocate out of the area. Out of area is defined as out of the PICYA region. To have a Non-Resident Membership, the Member must apply for approval to the PYC Board of Directors in writing. Other Boat Owners who live outside the PICYA area may also qualify for Non-Resident Membership. Visits to the PYC Clubhouse will be limited to no More than six (6) times year. A “Visit” is defined through a weekend, a vacation or if the Member is “in town”. Dues will be ~~25% of a full membership fee~~ paid annually including any assessment levied. This membership category has no voting rights.
- (4) **Cruising/Traveling Membership:** This status is temporary and available to existing members in good standing who will be cruising or traveling outside the PICYA area for the majority of the year. The “cruising” status must be renewed annually by written request to the PYC Board of Directors. Visits to the PYC Clubhouse will be limited to no more than six (6) times year. A “Visit” is defined through a weekend, a vacation or if the Member is “in town”. Dues will be ~~25% of a full membership fee~~ paid annually including any assessment levied. This membership category has no voting rights.
- (5) **Affiliate PICYA Member:** If prospective Members can show proof of being in good standing in any PICYA affiliated club, they may become Affiliate Members of PYC. ~~for one half the regular initiation fee and 25% of a Full Membership fee~~ Affiliate Memberships will pay any Initiation Fee upon application and annual dues including any assessment levied. This membership will have members’ names and contact information included in the roster and will receive official name tags. Such Members will have all privileges for the use of the Clubhouse during regular Club hours and may participate in an unlimited number of Club sponsored dinners and events. This membership category has no voting rights.
- (6) **Temporary or Guest Membership:** Temporary or Guest Memberships may be approved by the PYC Board of Directors for special promotions in conjunction with the City of Pittsburgh Harbormaster, local yacht sales office or other general membership campaigns. These memberships shall be for a stated period of time and may require a minimum dues payment by the temporary or guest members. Temporary or Guest memberships are not voting memberships.
- (7) **Corporate Membership:** A Corporation will pay an initiation fee and dues per card as recommended by the Budget and Finance Committee and approved by the Board of Directors. A corporation must purchase a minimum of two (2) corporate membership cards up to a maximum of twenty. Each membership card will bear the Corporate Employee name. The Corporate membership may have one vote only and may not hold office or serve as “Chairperson” of a Committee. The corporate membership includes two (2) membership cards and a business card size advertisement in the *Yeoman*.
- (8) **Life Membership:** Life Membership may be granted by vote of the Board of Directors to a member in good standing who has served a full term as Commodore of the Pittsburgh Yacht Club and has also been a Full or Individual Member of the Club continuously for twenty (20) years. Dues will be waived beginning January 1st of the Following year. Full privileges of membership will be granted to a spouse or domestic partner of the Life Member. The spouse/partner will pay annual dues. The Life member and the spouse/partner will be responsible for any assessment levied.

ARTICLE III - MEMBERSHIP FEES

Section 2 - Dues/Assessments

There shall be annual dues for each ~~couple and for each single~~ Membership of the Classifications of Membership as defined in Article II, Section 2 of these bylaws.

~~Each Member shall be entitled to one vote.~~ The amount of annual dues shall be recommended by the Budget and Finance Committee and reviewed by the Board of Directors. Any change in the amount of annual dues shall be brought to the Membership for voting approval.

~~Dues may be paid in two installments of equal amounts. The first installment shall be due January 1 and is delinquent January 31. The second installment shall be due February 1 and is delinquent March 1. If at least one half of the dues are not paid by February 1 or the remaining half is not paid by April 1, the delinquent Member shall be notified in writing that he/she is no longer a Member and therefore, not entitled to any privileges of the Pittsburgh Yacht Club unless other payment arrangements for that Member were approved by the Board of Directors. If the Member defaults on the Board approved payment schedule, the defaulting Member will be notified in writing that he/she is no longer a Member of the Pittsburgh Yacht Club.~~

Dues for Full and Individual Memberships may be paid in full or according to an installment plan approved by the Board of Directors. The first payment and the choice of payment plan for the year will be due in the month of January. No installment plan shall be available for non-voting, special, short-term or promotional memberships.

Members who do not pay their dues by thirty-one (31) days following the first day of the month due, will receive notice that they are in default. Appeal may be made to the Board of Directors which has the authority to grant a grace period or agree to a change in the installment plan. 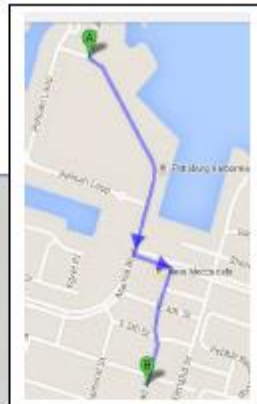
